CDI REQUIREMENTS FOR PARTICIPATION

The Contemporary Dance Invitational (CDI) is a concept designed to allow contemporary dance artists from the West Coast, a free venue at which to perform and share their passions with one another. This dance festival will affordably provide professional quality dance performances to California's Central Valley. The hosting company, Altered Modalities, will strive to promote positive and productive relationships between artists throughout the West Coast.

PERFORMING COMPANY REQUIREMENTS

1. The majority of the work presented must be contemporary in nature- be it modern or ballet or any combination there of.
2. The participating company must be available for both festival days- September 25th and 26th. Companies will be allotted technical/blocking times on stage the mornings prior to the concert.

PRESENTED WORK REQUIREMENTS

1. Presented work must be 10 minutes or less in running time.
2. The subject matter, music, costume, and gesture of the presented work must be appropriate for all audiences.

ADJUDICATION PROCESS

1. Complete and return the CDI application, a video/DVD of proposed work, a company biography, and choreographer biography.
2. All application packets, including video and application fee, must be received by May 15th, 2009, to be considered for adjudication.
3. If submitting more than 1 piece, please submit an extra \$15 per piece after the first \$25.
4. All applicants will be informed of the panel's decision by June 30th, 2009.
